CALL TO ORDER (Ms. Ann Motte, Vice Chairperson)

PLEDGE OF ALLEGIANCE

Vice Chairperson, Ann Motte led the pledge of allegiance

ROLL CALL (Establishment of a Quorum)

Virginia Frazier led roll call. Quorum was established. Members absent: Chairperson, Haile Ford and Cinthia Robbins

PUBLIC COMMENTS

Public comments were requested. No public comments were presented or submitted.

PRESENTATION/DISCUSSION/POSSIBLE ACTION ON MEETING MINUTES FROM October 4, 2006 FOR COMMITTEE APPROVAL

It was moved by Lurana Stewart and seconded by Victor Giardinelli to approve the October 4, 2006 meeting minutes with an amendment in the last sentence of the Discussion / Possible Action paragraph on page 2 to read "A request to re-address these dates was made by Vice-Chair Ann Motte to ensure that they will coincide with the absent committee members."

Jose Vallarta gave a presentation on the progress of the construction of Heritage High School which included a picture slide-show with aerial and ground photos. He reported there are multiple stages of construction taking place and that there are no major hindrances to hold up the project. Also noted, was change orders are minimal with the majority already figured into the project cost already. The remaining large bids will bid on February 1st with a 128 day timeframe for the off-site portion of the track and the electrical system.

Emmanuelle Reynolds noted that the loss ratio and the workers comp claims ratio have been very low.

Daryl Van Dran gave brief summary of Perris High School's improvements. There is a bid for the track and field surfaces to replace the natural grass field and dirt track for a synthetic track and field. To minimize the adverse effect on the sports programs, the project will start in April when the track season is over, however, the football program will be affected for one season. Once the track surface is completed, the replacement of the bleachers will begin with the home bleachers to have its own press box and the latest amenities. There will also be a replacement of 12 classrooms with modular permanent two-story building that will hold 14 classrooms; with this, the size of the bus drop-off area increases by eight feet. The phase III construction includes modernizing six classrooms with new lighting, paint, wall finishes, and updating the path of travel for accessibility to the new standards. This project will begin once the school year is over and should have the 6 remodeled classrooms available by the start of the 2007-08 school year. The estimated completion date for the track and field is May 2008. The bid date for the bleachers is February 6, 2007.

Emmanuelle Reynolds also reported that the school board is dedicating the new stadium at Heritage High School to County Supervisor Marion Ashley.

UPDATE ON MEASURE 'Z' BOND FUNDS EXPENDITURES

Emmanuelle Reynolds gave an update on the Measure Z Bond Fund. Explanation of the expenditure from the bond fund was given.

In respects for the Heritage High expenditures, the district has spent \$24,403,906.00 so far for the project. Of the Developer Fee Fund 25, the district has spent \$7.3 million. Of the State Fund 35, the district has spent \$24.9 million. The district has spent \$2.7 million from "Other Funds" which include Fund 40 and the CFD 92-1. The total Heritage project is about 57% complete.

In respect to the Perris High School Modernization, the modernization will begin at the end of the school year when students are no longer present on campus. There are six classes that will be modernized and twelve classes that will be destroyed and replaced by a two-story modular building that will hold 14 classrooms. The expense for the modernization, addition and track & field will be approximately \$11 million.

In respect for Paloma Valley High School, the project is 97.5% complete. The budget for this project was \$11,950,000 but the district is spending less than the budget by approximately \$318,000.
